Pioneer Showdown 2025 Hog Show Rules:

General Rules:

- 1. All entries made through the Showman App. Entry Fee is \$25/entry, \$30/entry day of show.
- 2. Open to any individual 21 & under as of January 1, 2025.
- 3. Animals should NOT arrive before 6:30 am on May 4th, 2025 unless prior arrangements have been made.
- 4. Trailers WILL BE STOPPED AT THE GATE TO REVIEW HEALTH PAPERS. Individuals not abiding by this will be asked to leave and will not be allowed to unload.
- 5. All animals MUST HAVE HEALTH PAPERS and be individually identified on the CVIs. All must include a statement that they are "free of diseases at time of inspection". ALL HEALTH PAPERS MUST INCLUDE THAT THE VETERINARIAN HAS INSPECTED THE ANIMAL WITHIN 30 DAYS OF MAY 4 TH.
- 6. All animals coming to the show must be from herds that have had a negative test for PRRS/PEDV within 90 days. That must be stated on the CVI and proof of test must be included. Please have your veterinarian go to this website and review the rules. Animals not meeting these specification will NOT BE ALLOWED TO UNLOAD and will be asked to leave. DATCP Home Swine Imported from a Commingled Market/Auction/Sale/Exhibition (Including Swine Returning to Wisconsin from Exhibitions/Shows)
- 7. Weigh-In will be from 7 to 9 am. NO EXCEPTIONS, NO DECLARED WEIGHTS.
- 8. Each breed will have their own class regardless of entry numbers. However, low entry classes may not receive equivalent awards. (Will follow the WSPA rules for classes under 3 entries).
- 9. The show will begin tentatively at 10 am with showmanship OLDEST to YOUNGEST.
- 10. All pigs must be born after November 1st, 2024.
- 11. There is no limit to the number of animals entered by 1 individual.
- 12. Awards given for class winners and breed champions will be pro-rated based on entries & at the discretion of the show officials.
- 13. Barrows & Gilts will be shown separately and Top 5 will be selected for both.
- 14. All purebreds must meet respective breed characteristics.
- 15. Show officials or WSPA executive boar members reserve the right to make the final interpretation of the show rules as the is a WSPA Sanctioned Show and we will be following WSPA Rules.

16. We respect and honor the International Show Ring Code of Ethics.
